Leptoprin Directions: Take two capsules with a full glass of water three times per day: morning, noon and early evening. You may take Leptoprin with or without food. Do not exceed 6 capsules per day. The recommended serving is two capsules three times a day, which is the exact serving used in the clinical trials. However, many people who are sensitive to stimulants have reduced the serving as low as one capsule twice a day and have still seen results. As with many ingestible compounds, each individual reacts differently to Leptoprin. The effective serving depends upon a person's body weight, metabolism, and overall health. You may want to start with one Leptoprin capsule twice a day and gradually increase the serving (up to the recommended level) until you find what works best for your body.
NOTE: Jitters, anxiety, dry mouth or insomnia may occur during the first week of use. Reducing number of capsules per day during the first week should eliminate these mild effects. WARNINGS: Consult your health-care provider before using this product. Do not take if sensitive to or if allergic to aspirin. Do not use if pregnant (it is especially important not to use aspirin during the last 3 months of pregnancy unless specifically directed to do so by a physician because it may cause problems in the unborn child or complications during delivery), nursing, have asthma, or have stomach problems (such as heartburn, upset stomach or stomach pain) that persist or recur, or if you have ulcers or bleeding problems, unless directed by a physician. Do not use if you are susceptible to ephedra psychosis. If ringing in the ears or temporary loss of hearing occurs, consult a physician before taking again.

DRUG INTERACTION PRECAUTION: Do not take this product if you are taking MAO inhibitors or a prescription drug for anticoagulation (thinning of the blood), diabetes, gout or arthritis, or any other prescription drug unless directed by a physician. Do not take this product if you have any of the following conditions: high blood pressure, cardiovascular disease, thyroid disease, prostate problems, or diabetes. This product is not intended for pain relief, fever, toothache, or any other analgesic effect.

Keep out of the reach of children. Children and teenagers should not use this product, or any other product containing aspirin, for chicken pox or flu symptoms before a physician is consulted about Reye Syndrome, a rare but serious illness reported to be associated with aspirin. In case of overdose, get medical help or contact a Poison Control Center right away.

WARNING: Not for use by individuals under the age of 18. Do not use if pregnant or nursing. Consult a physician or licensed qualified health care professional before using this product if you have, or have a family history of, heart disease, thyroid disease, diabetes, high blood pressure, recurrent headaches, depression or other psychiatric condition, glaucoma, difficulty in urinating, prostate enlargement, or seizure disorder, or if you are using a monoamine oxidase inhibitor (MAOI) or any other dietary supplement, prescription drug or over-the-counter drug containing ephedrine, pseudoephedrine or phenylpropanolamine (ingredients found in certain allergy, asthma, cough/cold, and weight-control products). Exceeding recommended serving may cause serious adverse health effects including heart attack and stroke. This product has 20 mg concentrated ephedrine group alkaloids per serving in the form of herbal extracts and may cause serious adverse health effects.

Discontinue use and call a physician or licensed health-care professional immediately if you experience rapid heartbeat, dizziness, severe headache, shortness of breath, or other similar symptoms. Consumption in excess of the recommended servings, or consumption of a serving at a more frequent interval than recommended, may cause serious adverse health effects, including heart attack and stroke. Individuals who consume caffeine with this product may experience serious adverse health effects.

ALCOHOL WARNING: If you consume 3 or more alcoholic drinks every day, ask your physician whether you should take aspirin. Aspirin may cause stomach bleeding.
